RE: **2020-2021 State Officer Elections**

The 2020 Washington DeMolay Convention will be held at the Great Wolf Lodge in Ground Mound, Washington from Thursday, April 23 to Sunday, April 26, 2020.

Pursuant to the Washington DeMolay Bylaws and direction of the Executive Officer in Washington, this Notice is given to all DeMolays interested in standing for election to a State Office. The deadline for submitting a Letter of Intent and supporting documents (Transcript, Parent Letter, and Advisory Council Letter) seeking approval to run for any of the following Elected State Officer positions: State Master Councilor, State Senior Councilor, and State Junior Councilor, is **POSTMARKED no later than February 9, 2020** (emails will not be accepted).

**A Letter of Intent is defined as a written letter, stating:**

- The full name, age / date of birth, mailing address, email, and phone number (cell and/or home) of the DeMolay Member requesting permission to run for office;
- The name of the DeMolay Chapter in Washington the member is from;
- The Elected State Office for which he is seeking approval to be a candidate;
- A listing of his qualifications to run for the desired office (see attached Eligibility Requirements to hold Elected State Office). Include DeMolay Chapter offices held and the number of members brought into DeMolay as a First-Line Signer;
- Copy of current school official or unofficial transcript. If graduated, a copy of Diploma or Degree equivalent.
- The reason(s) why he is running for Elected State Office and what he hopes to accomplish if elected to State Office (no less than 500 words, but no more than 1000);
- A signed and sealed confidential acknowledgement form signed by the candidate's Chairman and Chapter Dad Advisor. (Form and instructions provided with this Notice); and
- A letter signed by the candidate's parent(s) or legal guardian(s) giving their consent for their son to run for Elected State Office and acknowledgment that they have an understanding of the duties of the position and personal and financial responsibilities of being an Elected State Officer. (Sample provided with this Notice).

**All Letters of Intent and supporting documents to run for Elected State Office must be POSTMARKED no later than February 9, 2020 and must be mailed (hand delivered is acceptable) to:**

Executive Officer, Dad Brunson, has set forth the following Approval Process to stand for election:

1. **Monday, December 9, 2019** - Notice to Chapters requesting Letters of Intent to run for Elected State Office;
2. **Sunday, February 9, 2020** - Deadline to submit Letters of Intent and supporting documents to the Executive Officer. Must be Postmarked no later than the deadline date (hand delivered is acceptable, emailed Letters of Intent will NOT be accepted);
3. **Saturday, February 15, 2020** - Candidate Interviews (to be held prior to Leaders' Ball). Time schedule and location to be announced;
4. **Sunday, February 16, 2020, 12:00pm** - "So You Want to be A State Officer Meeting" (discussion with candidates and parents about the responsibilities of being an Elected State Officer and details of the election process and rules). Will be held at the WA DeMolay Offices in Tacoma from Noon to 1:30pm.
5. **Monday, February 17, 2020** – Official Announcement of approved candidates and written notice to all candidate applicants.

**Please note that:**

1. Informal campaigning for Elected State Office is not permitted until after official announcement of the approved candidates.
2. Formal campaigning is not permitted until the first day of Convention 2020.

**Washington State DeMolay Bylaws Article VI**  
**Section 2. Eligibility Requirements to Stand for Office**

- a. All Candidates.** To stand for election for an Elected State Office, a Candidate:
1. Must be an Active Washington DeMolay Member in good standing of a Washington State DeMolay Member Chapter in good standing and obtained his Proficiency Card;
  2. Must provide a copy of his School cumulative GPA Transcript. The candidate must have a minimum of a 2.0 GPA (or equivalent depending on his schools grading system) with no current failing classes to run for office. Candidates who have graduated must provide a copy of their Diploma or Degree equivalent;
  3. Must submit a statement signed by the candidate's parent(s) or legal guardian(s) giving their consent for their son to run for Elected State Office and acknowledge that they have an understanding of the duties of the position and personal and financial responsibilities of being an Elected State Officer; and
  4. The candidate's Chapter Advisory Council must submit a provided Candidate Form signed by the Chairman and Chapter Dad Advisor. This confidential Form provides for acknowledgement of candidacy, meeting of minimum requirements, and comments for consideration of final approval.
- b. State Master Councilor.** To stand for election for the office of State Master Councilor, a Candidate:
1. Must not have attained his twenty-first (21<sup>st</sup>) birthday at the time of election; and
  2. Must have served as the Deputy State Master Councilor prior to his election, or receive special dispensation from the Executive Officer.
- c. Deputy State Master Councilor.** To stand for election for the office of Deputy State Master Councilor, a Candidate:
1. Must not have attained his twentieth (20<sup>th</sup>) birthday at the time of election;
  2. Must have served as an Elected State Officer for at least one (1) term prior to his election, or receive special dispensation from the Executive Officer; and
  3. Must have successfully completed all lessons of the Leadership Correspondence Course (LCC) and received the Representative DeMolay (RD) Award;
- d. State Senior Councilor and State Junior Councilor.** To stand for election for the offices of State Senior Councilor or State Junior Councilor, a Candidate:
1. Must be a Past Master Councilor of a Washington State DeMolay Member Chapter;
  2. Must not have attained his twentieth (20<sup>th</sup>) birthday at the time of election;
  3. State Senior Councilor candidates must have submitted a complete application for the Representative DeMolay (RD) Award and have served either one (1) term as State Junior Councilor or have been awarded the Past Master Councilor's – Meritorious Service Award (PMC-MSA);
  4. Must have successfully completed the first three (3) lessons of the Leadership Correspondence Course (LCC); and
  5. Must be the First-Line Signer of at least three (3) DeMolay members;

## PARENT / GUARDIAN LETTER OF PERMISSION

**Instructions.** *This is a sample letter to be used as a guide for parent(s) and legal guardian(s) giving consent for their son to run for Elected State Office. An Elected State Officer is expected to provide a service to the Members of Washington DeMolay. As with all extra-curricular activities at a high level, this involves a considerable amount of time and travel around the state and, in some cases, outside of the jurisdiction. An Elected State Officer is expected to have the ability to communicate by cell phone and email and be able to travel to meetings and functions. While the Jurisdiction does provide a small budget for travel, many times an Elected State Officer will be purchasing meals away from home or paying for gas or event functions that are not reimbursed or are beyond the limits of their budget. Because we know that many times Elected State Officers call upon family support to bridge the additional expenses, we request that you provide a letter of support acknowledging that your son is seeking this office and that you have an understanding that, if elected, your son will have additional responsibilities that can and will require his time and reasonable travel.
